Building Goals for TWEC

As we continue to look into the possibility of a new headquarters building for Todd-Wadena Electric Cooperative, we are first and foremost concerned with how to best serve our membership. This means taking time to assess both the current and future needs of our cooperative.

Just as TWEC's Board of Directors has a responsibility to maintain and enhance the co-op's electrical distribution system, the Board is also responsible for maintaining and enhancing the facilities that serve the membership. Both are crucial to the long-term success of Todd-Wadena.

To further pursue the possibility of a new headquarters building, Todd-Wadena is working with *Contegrity Group* — a construction management company based out of Little Falls, Minnesota. Architects will develop designs and specifications based on input received from TWEC. A building committee, comprised of TWEC board members, CEO Dan Carlisle, and co-op employees, will then review building plans and offer feedback to help determine the most efficient design.

Once Todd-Wadena has the blueprint and specifications fully prepared, the Cooperative

will send out for bids. The goal is to utilize as many local contractors as possible. If the bids received are within our budget range, the Board will then move forward with construction on a new headquarters building.

If we move forward with a building project, one of the primary goals will be to offer members new opportunities to be involved with the Cooperative. We would have hands-on displays to learn about energy efficiency, rebates, and overall ways to interact with the Cooperative. Another goal is making sure we can conduct business in the most efficient way possible. A small conference room is being included in the design to provide a private and comfortable setting where members can meet with us. Equally important is providing a safer and more productive environment for employees and members.

As we take these important steps over the next few months, we will keep our members informed throughout the process. We appreciate your support as we plan today for the future of Todd-Wadena Electric Cooperative.

Four-Year Work Plans

Here at Todd-Wadena, our crews work year-round to provide members with safe, reliable, and affordable electricity. To accomplish the wide range of projects we face in any given year, we operate on four-year work plans.

These work plans, designed in large part by our electrical engineers, help us determine what needs to get accomplished each year. Tasks such as replacing undersized transformers, identifying and replacing old poles, and building new lines are all planned out in advance. This allows us to make sure we have necessary items such as the correct amount and type of poles in inventory, cement pads poured and ready to use, and the proper hardware required by Rural Utilities Service (RUS) for each pole assembly.

According to the 2016 Load Forecast and historical patterns, TWEC anticipated extending service to 373 new residential consumer locations during 2017-2020. The service extension cost for the 2017-2020 period was estimated at \$492,000. During this same four-year period, we anticipated 480 service capacity increases, with an estimated cost of \$800,000.

The four-year plan we are currently operating under also outlines recommended distribution line projects. This work plan calls for the building and replacement of 45.31 miles of line due to growth on the system, adding back feed capability between substations, and replacing old lines that have reached the end of their useful life. Also planned is 1.10 miles of new tie lines to address growth on TWEC's distribution system.

The Blueberry Substation was also included in the construction work plan period, replacing Todd-Wadena's former Menahga Substation. This new substation improved electrical service reliability in the Menahga area. Todd-Wadena co-located the Blueberry Substation with Great River Energy's new transmission substation.

In addition to these projects, our crews stay busy with line patrol, vegetation management, and a variety of other responsibilities around our system. We appreciate the hard work they put in to make sure our members have reliable power. Please respect our crews and help keep them safe by pulling over and giving them adequate working space.

Highlights from the November 27th, 2019, regular board meeting:

- CEO Dan Carlisle reported to the board on several meetings that took place during the month of November, including the most recent Member Managers Group meeting with Great River Energy (GRE). He also met with David Saggau, CEO of Great River Energy.
- Carlisle formed a new security committee. As part of the Cyber/IT division, the committee is looking at participating in the RC3 Cyber Security Assessment. This will be at zero cost to the Cooperative and will be grouped under GRE's license.
- Board members were presented with updated headquarters building drawings compiled by the building committee, staff, BHH Partners, and Contegriety. Discussion continued as questions and concerns were addressed.
- Lisa Graba-Meech, CFO, presented the financial report for October. The kWh sales in October were 3 percent over budget, with year-to-date sales 2 percent over budget. Monthly revenue was 3 percent over budget, with year-to-date revenue 1.6 percent over budget. TIER is 2.49 and Equity is 46.90.
- The board approved the Union agreement. A thorough review of wages for industry and position standards was conducted. The signed contract will be for a three-year term.
- Senior management presented TWEC's 2020 Budget. The board will be asked to act on the 2020 Budget and approve 2020 membership dues at the December board meeting.
- Member Services Manager Allison Uselman shared department updates with the board, including a quick update on generator tests, HomeServe, IFP status, meter interference for members, and the new satisfaction surveys.
- Operations Manager Todd Miller also provided department updates and reviewed how vegetation management will end for the year.
- Board Member Tom Brichacek was the guest director at November's GRE board meeting. He went over a few highlights from his visit, including but not limited to: corporate services, inventory values, neighboring industry rate changes, and strategic initiatives.
- Board Member Mike Thorson also shared a few highlights from the meeting. He expanded on the strategic initiatives and the order of creating the initiatives; the GRE Board of Directors will now have first input.
- Board Chair Miles Kuschel gave a few political updates related to the industry. There is a 100 percent clean economy act in Congress that would require the U.S. to become carbon neutral by 2050.

Todd-Wadena Electric Cooperative will award up to two \$1,000 *Power Up Non-Traditional Scholarships* to adult students who are headed to college for the first time, returning to complete an interrupted education, or looking to return to college to improve their career opportunities.

Where Do Funds for the Scholarships Come From?

After a period of seven years, Minnesota law allows cooperatives to use **unclaimed capital credits for charitable or educational purposes**. Each year, Todd-Wadena is able to use the unclaimed capital credits to offer student scholarships in our service area. This year, Todd-Wadena Electric Cooperative is offering up to six \$1,000 scholarships to graduating high school seniors, and up to two \$1,000 scholarships to non-traditional, adult students.

How to Become a Director

The grassroots participation in nominating and electing directors is one of the most important powers that you, the member-owners of Todd-Wadena Electric Cooperative, have to guide the decisions of your cooperative.

This year, the three-year terms of Gene Kern, Dale Adams, and Kristine Spadgenske will expire at the Annual Meeting on April 28th, 2020.

Election ballots will be mailed to all members in March 2020. There will again be an option to vote electronically this year. Members may also vote at the TWEC Annual Meeting on Tuesday, April 28th, 2020.

If you are interested in becoming a nominee for a director position, please note the following:

You must:

- Be a member in good standing of Todd-Wadena Electric Cooperative.
- Be only one, and not more than one, member of a joint membership.
- Not be employed by, materially affiliated with, or have a material financial interest in any individual or entity which is either directly or substantially competing with the Cooperative, selling goods or services in substantial quantity to the cooperative, or possess a substantial conflict of interest with the Cooperative.
- Not be an employee or have been an employee of the Cooperative within the last three (3) years.
- Not be a close relative of an employee.
- Have not been convicted of a felony within the last three (3) years.
- Agree to regularly attend all board, regular and special, members' meetings.

Explore Your Energy Usage With SmartHub


Did you know that you have the ability to investigate your kWh usage? SmartHub, a free online tool and mobile app available to all Todd-Wadena members, gives you the ability to view your electrical energy usage at monthly, daily, or hourly intervals for any date range.

You can also overlay an average temperature line over your usage to compare spikes to temperature fluctuations.

This is a great tool to help explain energy usage on your bill and assist you in making informed decisions about energy use. Visit our website and click on the “SmartHub” button to get started!

Where to Find Your Energy Usage

1. Log into SmartHub
2. Under the *My Usage* tab, click on Usage Explorer
3. View monthly, daily, or hourly usage and choose a pre-defined date range (*unbilled, current bill, last 24 hours, last 48 hours, last 72 hours*), or a specific date range and time.

Todd-Wadena Electric Cooperative is partnering with HomeServe to offer *optional* home coverages for our members. **Watch your mailbox for more information!** We value our members and are committed to providing you with safe and reliable electricity.

Many homeowners aren't aware that the exterior electrical lines and certain components on their property are their responsibility, including weatherhead, insulator, riser, meter base, and service entrance conductor. Todd-Wadena Electric Cooperative will still be responsible for maintaining all line up to the meter.

If a breakdown to these items occurs, it is up to the member to find an electrician and pay the repair costs. Todd-Wadena Electric Cooperative has selected **HomeServe** to offer *optional Exterior Electrical Line Coverage* for our members. Watch your mailbox for more information coming soon.

Operation Round Up is a voluntary, member-driven fundraising program for local community projects. Since the program's inception in 2002, Todd-Wadena members have raised and donated more than \$523,000 for nearly 700 local community service projects!

Each year, Todd-Wadena Electric Cooperative holds a contest to select one local sophomore or junior high school student to attend the NRECA Youth Tour. This trip to Washington, D.C. is an all-expenses paid trip to see our nation's capital, during **June 20th-25th, 2020**. The winner will travel with approximately 40 other Minnesota teens, and join 1,500 students from across the nation during the Youth Tour. Participants will learn about cooperatives, visit with legislators at the Capitol, see the national monuments, and make memories that will last a lifetime.

The contest is open to sophomores and juniors whose parents/guardians are Todd-Wadena Electric Cooperative members. Students must submit an application including a one-page typed essay explaining why they wish to attend the 2020 Rural Electric Youth Tour to Washington, D.C. **Applications must be received by February 14th, 2020.**

Students with the top applications and essays will be invited back for an interview. An interview committee determines the winner, basing the decision on written and verbal responses during the brief interviews, which will be held in early March.

First, make sure the problem is not on your side. (*Members may be billed for service calls if the problem is caused by their own equipment.*) Check fuses and circuit breakers in your home and by the meter pole. (*Call us for help, if necessary.*)

Second, check with your neighbors to see if they have power. Then call Todd-Wadena to report the problem. Give your name and account number. Then report any tree branches, twisted wires, broken poles, and whether or not your neighbors are also out of power.
