### **Coal Creek Closure**

Todd-Wadena Electric Cooperative's wholesale power provider, Great River Energy (GRE), recently announced plans to transform its portfolio of power supply resources in the coming years. One element of this includes the retirement of the 1,151-megawatt Coal Creek Station power plant in the second half of 2022.

As part of the plan to increase economic efficiencies, GRE plans to phase out remaining coal resources, add significant renewable energy, and explore critical grid-scale battery technology. Each of these steps is an important part of GRE's plan to significantly reduce member-owner wholesale power costs, while taking advantage of cost-competitive renewables and reliable access to market energy.

Although the decision to close Coal Creek Station will have a dramatic impact on the North Dakota communities that rely upon it for employment and economic benefits, the decision ultimately came down to what was in the long-term best interest of GRE's member-owner cooperatives such as Todd-Wadena Electric Cooperative. To continue to pay for the plant's losses each year, when there was a practical alternative available, ultimately led to the decision to close Coal Creek.

Despite what you might read or hear from some news sources, GRE did put a lot of thought into this decision and has made every effort to be transparent, honest, and fair with the communities in North Dakota that are affected the most. This includes voluntarily making payments to these communities for several years after the plant closes, to relieve some of the immediate impact of lost tax revenue.

Great River Energy's portfolio changes will significantly reduce its power supply costs. The new power supply plan takes into consideration affordability, reliability, and environmental stewardship – three necessary components to ensure GRE's member-owner electric cooperatives, like Todd-Wadena Electric Cooperative, are well positioned for the future.



### **Board Minutes**

# Highlights from the April 30th, 2020, regular board meeting:

- TWEC's board approved the continuing resolutions and MREA By-law changes.
- CEO Dan Carlisle reported on the review conducted by Federated Insurance that consisted of a three-year loss summary.
- A short update on the headquarters building project was provided. Footings are being poured and the crew is approximately a week ahead of schedule.
- TWEC decided to self-serve its electricity needs for the new HQ building and property. The Building Committee was authorized to purchase a generator.
- Lisa Graba-Meech, CFO, presented the March financials to the board. Monthly kWh sales were 6.6 percent under budget. Energy revenue was 6 percent under budget. March's purchased power expense was 16 percent under budget. Tier is 2.56 and Equity is 43.89.
- TWEC held a Bifurcated Annual Meeting that was streamed live for members on Tuesday, April 28, 2020. The second half of the meeting will be scheduled and held as soon as it is safe to do so.
- The Board reviewed and approved the delegates and alternates for various cooperative committees. Dale Adams was appointed to the STAR Energy Board.
- Member Services Manager Allison Uselman shared updates on the collaboration between TWEC, WCTA, and CTC; the status of implementing prepaid metering; spring irrigation control; and a plan to elect individuals for the Nominating Committee.
- Operations Manager Todd Miller discussed safety procedures in place for the operations crew and his intent of running split crews, as well as starting the maintenance crew on tree trimming.
- Board Member Mike Thorson presented the Great River Energy (GRE) report. GRE held its annual meeting on April 1<sup>st</sup>, 2020. Three new board members were appointed and officers were reelected. GRE's board recently approved \$3 million in COVID-19 relief dollars for member-owners. The funds will be released in a three-month process; TWEC has received its first round of relief of \$13,000.
- Board Member Dale Adams attended the STAR
   Energy Board meeting remotely in April. The 2019
   audit was reviewed. STAR Energy continues to show
   slow and steady growth.

# How to Save Energy While Working From Home

You may be working from home and wondering about increased electricity costs. The good news is there are ways to keep your electricity bill under control. Here are a few tips for saving energy as you work from home.

### **Tips to Help You Monitor Your Energy Usage**

Monitor your usage with SmartHub, TWEC's free tool for account management. SmartHub can help you take control of your account and gives you the chance to focus on smart energy choices for your household.

You can schedule payments, set up alerts, recurring payments, and view billing history. Additionally, you can see your current bill, along with statements from the previous month or even the previous summer, if you want to com-

pare costs. You can view your actual usage by the hour, day, month, or year and see how your usage is trending over time, which allows you to take steps to lower your bill.


### **Economic Savings**

EVs are less expensive to own and operate than a traditional gas-powered vehicle over the long-term. While they can sometimes cost more to purchase, the federal government offers consumers a tax credit of up to \$7,500 to put toward the purchase of most new EVs. A typical EV can travel about 43 miles on \$1 worth of electricity. Also, EVs have fewer moving parts to break down which means they're more reliable than their gasoline-powered counterparts. Very little maintenance is required beyond changing windshield wipers and tires—no more oil changes!



#### Convenience

Charge from the convenience of your home with our low EV rates and special rebates on chargers. There are two rate options: a storage rate, which allows charging only during certain hours, and a time-of-use rate, which has different rates depending on the time you charge your vehicle. ## The Dreaded Vampire Loads By Tom Tate

Perhaps you are familiar with an undesirable aspect of the electronic revolution: *vampire loads*. Vampire loads come from devices that use electricity even when they appear to be off. The primary culprits are chargers, set-top television boxes, instant-on televisions, and gaming systems. There are others, but these four represent the major offenders.

Let's look at how these vampire loads occur and why they are approaching 10 percent of average household electric use according to the Environmental Protection Agency.

Chargers take the 120 VAC (volts alternating current) power at the outlet and reduce it down to the voltage required by the connected device, usually 5 to 12 VDC (volts direct current). Obviously, when your device is charging, the charger is using electricity, but you might be surprised to learn that chargers are still using small amounts of energy even when they're not connected to a device.

Television set-top boxes also consume energy when they appear to be inactive. Anytime the set-top box's lights are on, it is using power. Like chargers, they use more when the television is on, but they are always working—even when the TV is off. This is especially true for those devices with a DVR function that records your favorite TV shows.

The instant-on television is another culprit. The intention of the "instant-on" feature is instant gratification for the viewer, meaning no waiting for the TV to start up. Unfortunately, for that convenience, the TV must be on at nearly full power. So, in this mode, it can be a real energy drain.

The typical gaming console can use as much energy as a regular refrigerator even when it's not being used. Games on the console are frequently updated, which requires a lot of electricity.

Here are a few suggestions to change how you handle these energy-sucking electronics.

- Unplug chargers when not in use.
- Invest in smart power strips. These look like normal power strips but have a twist; one of the outlets is the "master" that receives power all the time. The others are off. When the device connected to the master outlet turns on, the rest of the outlets receive power too. Ingenious and perfect for entertainment set ups. Have the television in the master outlet and when you turn it on, the set-top box, speakers, streaming devices, etc. will turn on too. They are also ideal for PCs and their peripherals.
- Turn off the instant-on function on your TV. Turn off set-top boxes that do not contain the DVR functionality or use a smart power strip.
- Disable automatic updates in gaming consoles and turn the console completely off when you finish using it.
- When replacing any device or appliance, look for an Energy Star rated product.


Vampire loads are a real problem that will only continue to grow as the digital age advances. But you can fight the vampires with vigilance and application of the recommendations above.

# The Cost of Running Your Dehumidifier

Dehumidifiers reduce humidity levels, and can help reduce allergens in your home. Many people plug in the dehumidifier and run it until it needs to be emptied. Keep in mind that running a dehumidifier 24/7

will increase your energy bill.

You can figure out how much it costs to run your dehumidifier by using the equation below.



To calculate our usage we used this formula:

 $Watts/1,000 \times Hours = kWh usage$ 

Our dehumidifier used 745 watts.

 $(745w/1,000) \times 24 \text{ hours a day x}$ 11.5 cents/kWh = \$2.05

 $$2.05 \times 30 \text{ days} = $61.50$ 

If you run the dehumidifier for 30 days, that would add an additional \$61.50 to your bill. Many people will run the dehumidifier during late spring, summer, and

early fall. Dehumidifiers may be a need for some households. Todd-Wadena offers a \$25 rebate for members who purchase an Energy Star rated dehumidifier.


# **Energy Efficiency** Tip of the Month

First, make sure the problem is not on your side. (Members may be billed for service calls if the problem is caused by their own equipment.) Check fuses and circuit breakers in your home and by the meter pole. (Call us for help, if necessary.)

Second, check with your neighbors to see if they have power. Then call Todd-Wadena to report the problem. Give your name and account number. Then report any tree branches, twisted wires, broken poles, and whether or not your neighbors are also out of power.
