#### **CEO's Message**

Governance in electric cooperatives encompasses a range

of activities and structures aimed at promoting transparency, accountability, and member participation. It is the mechanism through which the cooperative's values and priorities are upheld, and decisions are made in the best interest of the membership.

Key aspects of effective governance include:

- 1) *Democratic Member Control:* Electric cooperatives operate under the principle of "one member, one vote," ensuring that each member has an equal say in the cooperative's affairs, regardless of the member's electricity consumption or financial contribution. This democratic structure empowers members to elect representatives to the board of directors and participate in important decisions affecting the cooperative.
- 2) *Board of Directors:* The board of directors serve as the governing body of the electric cooperative. It is responsible for setting strategic direction and representing the interests of the membership. Directors are elected by the members and are entrusted with upholding the cooperative's mission, values, and fiduciary duties.
- 3) *Transparency and Accountability:* Electric cooperatives are expected to operate with transparency, providing members with access to information about governance, finances, and operations. Regular communication and financial reporting help build trust and confidence among members, ensuring accountability to the communities served.
- 4) *Member Engagement:* Engaging members in the governance process is essential for ensuring that the cooperative remains responsive to their needs and priorities. Opportunities for member participation, such as annual meetings, member forums, and surveys, enable cooperative leadership to gather feedback and insights that inform decision-making.

Effective governance is one of the cornerstones of electric cooperatives' success. It is evident in every aspect of what we do, especially Todd-Wadena's election and annual meeting. As an owner of Todd-Wadena Electric Cooperative, please take the opportunity to participate in the democratic process by voting for your board of directors and attending the annual meeting on April 16<sup>th</sup>. # **TWEC Board Minutes**

#### Highlights from the January 25<sup>th</sup>, 2024, regular board meeting:

- Member & Energy Services Manager Allison Frederickson shared a few department highlights from 2023: the member survey surpassing the strategic goal and stretch goal, by reaching a 97% satisfaction rating for the different services members received throughout the year; the Community Ambassador Program providing 62.5 hours of community service in TWEC's territory; and the rebate program providing over 680,000 kWh savings in beneficial electrification.
- CEO Dan Carlisle attended the recent CEO Close Up and shared highlights from the conference. The seminars focused on communication and leadership skill awareness and building; workforce challenges; and Artificial Intelligence in the electric industry.
- Board Member Mike Thorson gave the GRE report, noting how 2023 ended financially strong. Assets in 2023 performed extremely well and greatly benefited from the wind contracts.
- Lisa Graba-Meech, CFO, presented the December and 2023 Year-End financials to the board. December kWh sales were 12 percent under budget, year-end 1.6 percent under budget. Monthly energy revenue was 2 percent over budget, year-end 3 percent over budget. December's purchased power expense was 15 percent under budget, year-end 4.5 percent under budget. Tier is 2.38 and Equity is 40.33.
- Management compiled and included in the board packet the annual year-end reports.
- Operations Manager Tyler Fisher recapped December and year-end construction and outage reports. Operations installed 112 new services, 51 service upgrades, and constructed over 62,000 feet of new line.
- Board Chair Miles Kuschel discussed the MISO region and how pricing varies across it.

Results of the balloting will be announced at the close of the Annual Meeting on April 16<sup>th</sup> and printed in the May issue of *Pine to Prairie News*.

### 2024 Director Candidate Voting Options

Cooperatives are <u>democratic entities</u>, owned by those they serve and governed by elected representatives. In fact, one of the seven cooperative principles is *Democratic Member Control*. In order to underscore this principle, we offer multiple ways to cast your vote. This year you can vote for up to **two candidates**, who will each serve a three-year term ending in 2027.

#### VOTE BY MAIL OR DROP BOX

Election ballots are scheduled to be mailed to all Todd-Wadena members on March 11<sup>th</sup>. The ballots will look like the sample to the right. The order of candidate names will be rotated among ballots.

To vote by mail, complete your ballot, place ballot in secret envelope, and seal. Place secret ballot envelope in the yellow, pre-paid return envelope, and mail. The ballots will be mailed directly to our election company, OSG, to tabulate. **Your ballot must be received by April 16<sup>th</sup>, 2024**.

**OR** Seal your completed ballot in the appropriate envelopes and place it in the drop box located outside of Todd-Wadena Electric Cooperative's office by **9:00 a.m. on April 8<sup>th</sup>, 2024**.

There are two envelopes to be returned with each ballot. One is the **pre-addressed**, **postage-paid** envelope, and the other is the **secret ballot envelope**. It is very important that the ballot is first placed into the secret ballot envelope, and then that envelope is placed into the pre-addressed envelope to be mailed. **If the ballots are not in a secret ballot envelope they cannot be counted as a valid vote**.



# 2024 Board Candidates

## Tom Brichacek

### Miles Kuschel

Miles attended school in Sebeka and then earned a degree in Beef Production from the UW-Madison Farm & Industry Short Course. He has served various roles within the Cass Co. Farm Bureau, American Farm Bureau Young Farmers and Ranchers, Ansel Township Board, and recently served on the FCC Broadband Task Force, Data and Mapping Group. He also serves as a District Director for the MN Farm Bureau State Board. Miles volunteers for 4-H, FFA, and Second Harvest Heartland, among others.

Miles has spent much of his term on the TWEC Board advocating for a reliable and affordable electric supply and continues to promote Beneficial Electrification. He continues to work with both state and federal legislators to ensure they understand how the rules and regulations affect our members of today and tomorrow. Miles' focus for the upcoming term will be on managing inflation, increasing broadband access, meeting members' expectations, and promoting youth involvement.

Todd-Wadena Electric Cooperative's Community Trust Board met in early February and awarded six Operation Round Up grants to local non-profit organizations, totaling \$12,183.57.

Funds for the Operation Round Up program come from participating Todd-Wadena Electric Cooperative members who allow their monthly electric bills to be rounded up to the nearest dollar, with the change allocated to a Community Trust Fund. The average donation is less than 50 cents a month, yet together, members raise and donate about \$29,000 annually to community service projects in the TWEC service area. Since the program's inception in 2002, Todd-Wadena members have raised and donated more than **\$643,000** for **772** local community projects.

Todd-Wadena's Operation Round Up grant applications are reviewed and recipients selected three times a year by a seven-member volunteer Community Trust Board. **The next application deadline is May 15<sup>th</sup>.** Local, nonprofit community service groups may apply for Operation Round Up grants by downloading a copy of the application form and guidelines at *www.toddwadena.coop/oru*

#### Annual Cogeneration Notification to Membership

In compliance with Todd-Wadena Electric Cooperative adopted rules relating to cogeneration and small power production, Todd-Wadena Electric Cooperative is obligated to interconnect with and purchase electricity from cogenerators and small power producers who satisfy the conditions as a Qualifying Facility. Todd-Wadena Electric Cooperative is obligated to provide information free of charge to all interested members upon request regarding rates and interconnection requirements. All interconnections require an application and approval to become a qualifying facility. Any dispute over interconnections, sales, and purchases is subject to resolution by the Todd-Wadena Electric Cooperative Board. ## **Vegetation Management: Right-of-Way and Spraying**

When you become a member of Todd-Wadena Electric Cooperative, you are agreeing to abide by all co-op policies. TWEC's tree trimming policy is as follows:

Primary lines (other than those in yards) will be maintained a <u>minimum of 20 feet horizontal clearance</u> on each side of the pole line from the ground up. Overhead primary lines located in members' yards are maintained <u>10 feet minimum horizontal</u> <u>right-of-way</u> on each side of the pole line. On three-phase power lines located in members' yards, the right-of-way must be maintained <u>15 feet from outside lines and 10 feet below</u> <u>the neutral line</u>. Outside of the right-of-way we also look for "danger trees"—dead or leaning trees that will touch the line if they fall, causing an outage or blinking lights.

This policy allows TWEC to responsibly provide safe and reliable energy to our members. The process of implementing this policy is called *Vegetation Management*. Strategies used to minimize vegetation growth that could cause issues near power lines include tree pruning, brush removal, mowing, and spraying.

TWEC Arborist Joe Sworski is responsible for lining up work for TWEC crews and our vegetation management contractor Carr's Tree Service. Work consists of side trimming, removals, and mowing. Our goal is to reach all areas of our system once every seven years. This helps us keep the lights on and the blink count minimal.

This spring, TWEC is mowing and spraying all circuits coming out of the *Compton, Leaf River, Sebeka*, and *Thomastown* substations. TWEC has contracted this service out to **Central Applicators**. Central Applicators will notify members in those areas on the timeline of the spraying via a letter in the mail.

**Please read this letter completely and let Central Applicators know if there are any issues.** Look for their logo on the letter/envelope (pictured to the right).

#### If your electric power goes out:

First, make sure the problem is not on your side. (Members may be billed for service calls if the problem is caused by their own equipment.) Check fuses and circuit breakers in your home and by the meter pole. (Call us for help, if necessary.)

Second, check with your neighbors to see if they have power. Then call Todd-Wadena to report the problem. Give your name and account number. Then report any tree branches, twisted wires, broken poles, and whether or not your neighbors are also out of power.
