The best way to ensure efficient operation of your central air conditioner (CAC) or air-source heat pump (ASHP) is by having it tuned-up every two years. A tune-up by a service expert can improve your unit's efficiency by as much as 20 percent, extend its life, and help protect our environment. Contact a local HVAC service contractor. - Rebate submittal must follow the guidelines as listed.
- Program is subject to change or cancellation without notice. Call TWEC to verify rebate status.
- Rebate is for tune-ups only; it does not cover the cost for repairs of the CAC or ASHP.
- Rebate credits under \$100 will be applied to the member's account.
